As per provision of section 65 (4) of Maharashtra University of Health Sciences Act 1998, I am directed to inform you that, on the basis of Local Inquiry Committee report and permission from Academic Council vide Resolution No. 415/2025 dated 09/12/2025 the Hon'ble Vice Chancellor is pleased to grant First Time Affiliation to **Mauli Ayurved Medical College and Research Centre, At – Tondar Pati, Tondar, Tal. Udgir, Dist. Latur (Maharashtra)** established by **Mauli Shikshan Prasarak Mandal, At post Apegaon, Tal. Paithan, Dist. Chhtrapati Sambhajinagar (Maharashtra)** for the Academic Year **2025-26** with **100 intake capacity for B.A.M.S. (UG) Course**.

However, the affiliation is subject to the following conditions: -

- 1) Fulfilment of norms and conditions laid down by Central Council of Indian Medicine / National Commission for Indian System of Medicine, (NCISM) and Govt. of India.
- 2) Rules and Regulations made by the Govt. and the University, as amended from time to time, will be binding on the College.
- 3) The college should obtain the permission for admitting the students from the Admission Regulating Authority, Mumbai.
- 4) The college should obtain approval of fee schedule for the admission of the students from the Fee Regulating Authority, Mumbai.

- 5) The college should obtain approval / recognition of teachers from Maharashtra University of Health Sciences, Nashik.
- 6) This First Time Affiliation to start B.A.M.S. (UG) course with **100** intake capacity is valid for Academic Year **2025-26** only.
- 7) The next batch of students shall not be admitted unless Continuation of Affiliation of MUHS, is obtained by college/Institute.
- 8) The college shall not admit the students for the Academic Year **2025-26** after the cut-off date prescribed by the CCIM /(NCISM), New Delhi.
- 9) The students shall be admitted only after obtaining the permission of concern council & competent Authority of the State Govt.
- 10) It is mandatory for the College / Institute to register on AISHE portal and submit the required data on AISHE portal time to time.
- 11) Verification of original land, building etc. documents within period of 06 months.
